On such treated surfaces the cured performance of LOCTITE<sup>®</sup> cyanoacrylate adhesives is generally similar to that described in the TDS for the relevant adhesive. LOCTITE<sup>®</sup> SF 7951<sup>™</sup> is only recommended for difficult to bond substrates which include polyethylene, polypropylene, polytetrafluoroethylene (PTFE) and thermoplastic rubber materials. LOCTITE<sup>®</sup> SF 7951<sup>™</sup> Polyolefin Primer is not recommended in assemblies where high peel strength is required. The product is non-flammable.

#### **GENERAL INFORMATION**

This product is not recommended for use in pure oxygen and/or oxygen rich systems and should not be selected with a sealant for chlorine or other strong oxidizing materials.

Under no circumstances should primer and adhesive be mixed directly as liquids. Use only in a well ventilated area. This product is intended for post-activation.

Where aqueous washing systems are used to clean the surfaces before bonding, it is important to check for compatibility of the washing solution with the adhesive. In some cases these aqueous washes can affect the cure and performance of the adhesive.

#### **Handling precautions**

The solvent can affect certain plastics or coatings. It is recommended to check all surfaces for compatibility before use.

#### Directions for use:

- 1. Primer may be applied by spraying, brushing or dipping at ambient temperature.
- 2. Only one coat of primer is recommended.
- 3. Allow primer to dry before application of adhesive.
- 4. If polyolefin and more active or easier to bond materials are involved, apply the primer to the polyolefin only.
